In making this application, I understand and agree that:

All memberships are subject to the approval of the management of The Racquet Club of Columbus.

No member may sell or transfer his/her membership.

Membership fees are non-refundable.

It is understood that the prospective member assumes no liabilities whatsoever in connection with this membership other than that of payment of membership fees, court charges, usage fees, professional instruction fees, and other charges incurred by the member and his or her family and guests in the use of the Club.

Membership fees, court usage fees, professional instruction fees, and other charges incurred by the member and his or her family and guests in the use of the Club are nonrefundable and subject to change (such charges and fees will not be applied retroactively).

Food, drinks, smoking, and chewing gum are not permitted on the courts any time.

Lockers are available for daily use only. Locks may not be left on lockers once user leaves at end of the day.

As a courtesy to the Club and its members, all members and guests must wear neat and proper attire at all times.

Members will receive a monthly statement, payment of which is due upon receipt and by the end of the month. The Club may assess finance charges on delinquent accounts. Finance charges are not refundable.

Season/Permanent Courts...We offer seasonal tennis and racquetball reservations which assures the same court each week at a reduced court fee. This permanent court time, however, commits the member for that court reservation for the entire season. Permanent courts are billed automatically and do not require a member's signature for billing. Permanent court time may be offered for sale at the request of the member. We will make every effort to sell this court. If it is sold, member will not be billed.

One time Only Courts...One time only court reservations may be made up to seven days in advance. There will be no charge for reserved court time if cancellations are received at least 24 hours in advance. "No shows" or courts cancelled less than 24 hours in advance will be charged the full rate. We will make every effort to sell court time available due to cancellation. If it is sold, member will not be billed.

Guests...Guests must sign in at the Front Desk prior to going onto the court. Each person may be a guest at the Club up to three times a year. The guest fee is \$6 per person per visit.

Please, go onto the courts only at the start of your scheduled court time, and be prompt leaving the courts at the conclusion of your scheduled court time.

Reservations for unreserved courts maybe made up to one week in advance. Such reservations will be charged unless cancelled at least 24 hours before the scheduled reservation time.

Children must be under direct adult supervision at all times. Children under 13 must not and can not be left unattended in the lounges. Experience indicates that unsupervised or unattended children of any age can be a disturbance and distraction to our members and guest. Children can not be left without direct supervision in the lounges while the parent or guardian is playing tennis or racquetball. Children may not go onto the tennis or racquetball courts for any reason unless they are actively playing tennis or racquetball under direct adult supervision.
